##### Winterbourne

##### Frenchay

- b) **P24/02067/HH - 20 Park Crescent Frenchay** (Erection of a two storey rear extension to form additional living accommodation). **RESOLVED**, The Parish Council did not raise an objection. However, the Parish Council have concerns regarding adequate parking.

- c) **P24/02027/CLP - 8 Oxleigh Way Stoke Gifford** (Erection of a single storey side extension). **RESOLVED**, The Parish Council raise an objection. The Parish Council have concerns that this is not a residential development but a letting business development which could impact the neighbouring properties.
